- The State Govt. reserves the right to withdraw the above certificate at any time without giving prior notice and without assigning any reason if any deviation of rules reported in future and the management falls to comply with the instructions of the State Government.
- 6) Staff salaries should be paid as per Govt. Pay Scale.

It will be mandatory for the school to provide information about the details of classes 8) and number of students to Education Officer (Primary & Secondary) before 31st

August of every academic year.
