- 6) Staff salaries should be paid as per Govt. Pay Scale.

The management should not demand donations either from the students or from 7) parents.

8) It will be mandatory for the school to provide information about the details of classes and number of students to Education Officer (Primary & Secondary) before 31st

August of every academic year.

The management shall follow the traffic and safety guidelines indicated by the Police. 9) Fire Services and Transport Department from time to time. The instructions issued in Circular Memo No. 21748/DI/97 dated 16/2/1998 and No. PRE-2008/506/11/Prashi-1 dated 14/7/2011 & other orders of transport department for safe transportation of school children should be scrupulously followed.
